## Ushering in a wave of rural transformation

 Suri and Edda Sehgal-monitoring progress in a village in India Desiring to accelerate development in rural India, the Sehgals formed a foundation 20 years ago that is making a positive impact and changing lives

hough Mahatma Gandhi long ago lamented that India's villagers had "lost all hope . . . They suspect that every stranger's hand is at their throats and that he goes to them only to exploit them," his observation is still a reality for many who live in poverty in the 840,000 villages in rural India. Against such a backdrop is

Sehgal Foundation, a welcome NGO that provides hope where there was despair.

The first time Edda Sehgal, who founded SM Sehgal Foundation in 1999 with her husband Dr. Suri Sehgal, visited the rural villages in Mewat, where Sehgal Foundation would start its work in India, "she looked into the faces of women and was struck by what she saw in their eyes. She said, 'There was this sense of total hopelessness. These people had nothing . . . not even clean water to drink. A woman we spoke to said, 'India has forgotten us.'"

The Sehgals chose to work in Mewat, now Nuh, about 50 km from the millennium city, Gurgaon, now Gurugram, because the social indices in the Mewat district were the lowest in rural India. The Sehgals felt that if they could bring positive change to such an impoverished place, they would be able to make sustainable changes elsewhere as well.

Not too long after the work began, Edda Sehgal saw the eyes of women and girls begin to light up as they were given opportunities to learn a simple skill such as stitching cloth. Edda said, "This was touching to us. These people were anxious to have opportunities. They liked what they were learning. We were excited too, to see these young girls blossom."

The work that began 20 years ago entailed lots of experimentation and learning by doing, and strategies have adapted as needed over the years, but the Sehgal Foundation team has maintained its fundamental approach. Sticking to core values, honesty, and transparency were essential for establishing trust with the villagers, and working alongside communities was the key to creating impact and sustainable change.

However, despite Sehgal Foundation's diverse and expanding work in hundreds of rural villages where incremental progress has been made, these communities remain underdeveloped, isolated, and still forgotten for the most part. "Inclusive growth" is a catchphrase that has not yet lived up to its promise. The Sehgal Foundation team has learned that, while furthering the well-being of rural communities in India requires

patience, the basic ingredients for transformation are already present even in the midst of formidable challenges. This is where hope lies.

In order to tackle the generationsold local customs, ingrained myths, widespread illiteracy, and community indifference in a traditionally unequal society, rural citizens and their villagelevel institutions must be supported and strengthened with the knowledge, skills, and inspiration to take charge of their own destiny. Continuing to work alongside communities to achieve these ends is the key to accelerating development in rural India.

According to Suri Sehgal, "Development is a path that, while often full of progress, never ends.
